2023 Real Estate & Personal Property Taxes

1st installment tax payments need to be postmarked by January 31, 2024 to be considered timely.

Tax payments can be made in person at the Town Hall, by mail or online.

1. The Treasurer will accept tax payments at the Town Hall on the following dates:

- Wednesday Dec 13th: 12pm – 6pm
- Friday Dec 15th: 11am – 4pm
- Wednesday Dec 27th: 10am – 4pm
- Friday Dec 29th: 11am – 6pm
- Friday Jan 5th: 10am – 2pm
- Friday Jan 12th: 10am – 4pm
- Wednesday Jan 24th: 12pm – 6pm
- Wednesday Jan 31st: 10am – 2pm

When searching for your property tax record(s) first select our Municipality: 11040 – Town of West Point.

You can search by parcel number, last name, street name, etc. “Less is more” when it comes to searching. For instance, search for just your last name OR your street name, but NOT both.

Click on the red parcel link and then select the Taxes option in the Select Detail dropdown.

TRANSFER SITE

2024 Dog Licenses



Wisconsin State Statues 174.05 and 174.07(1)(b) requires ALL DOGS over the age of 5 months to be licensed **annually** by the Municipal Treasurer. Licensing your dog requires proof of rabies vaccination.

Licensing fees:

- \$5 for spayed or neutered dogs
- \$10 for unspayed or unneutered dogs.

Please include a self-addressed stamped envelope along with your payment when purchasing via mail. *Note: extra postage is required when licensing multiple dogs.*

PLEASE NOTE

Columbia County has gone to a new Dog Licensing system. It will be very important that you bring proof of rabies vaccination when licensing your dog. Previous information will not transfer over.
