To: Residents of Pleasant View Park Plat,

In December of 2023 the Town of West Point hired Grothman & Associates to complete an Assessor's Plat for the Pleasant View Park and Weast Park to "remove the promenade."

In order to complete the Assessor's Plat, the agreement required the surveyor to draw new property boundaries across the promenades and divide the land appropriately between the landholders so that all properties appearing to have lake shore will own lakeshore.

Grothman & Associates is completing a "draft" map for the Assessor's Plat for the Pleasant View Park area and would like to present it to landowners to address any questions, comments, and concerns.

The Town of West Point has scheduled the meeting at the West Point Town Hall on **Thursday, October 24, 2024 at 6:00pm for the "bay area" and at 6:30pm for the rest of the Pleasant View Park area.** Grothman & Associates will introduce the "draft" map for the Assessors Plat, review the process, and answer questions.
