Stat. §§7.51 and 7.53(1). This meeting will be open to the public pursuant to Wis. Stat. §§ 19.81-89.

Notice of Meeting of MBOC to Process Rehabilitated Provisional Ballots

If provisional ballots have been issued and are subsequently cured by the voter before 4:00p.m. on the Friday after the election, the MBOC must meet no later than the Following Monday at 9:00a.m. to process the cured provisional ballots. This is a public meeting and requires applicable notice.
